What is the overall <u>deductible</u> ?	In-Network: \$1,500 Individual/\$3,000 Family Member/\$3,000 Family Total. Out-of-Network: \$3,000 Individual/ \$6,000 Family Member/\$6,000 Family Total.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. 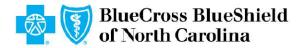
About these Coverage Examples:
